## SOUTHERN CAPITAL FORUM 2016 MEMBERSHIP APPLICATION

To: All 2015 Members and Prospective 2016 Members

The FOCUS of the *Southern Capital Forum* is on direct participants in the risk capital investment process. The membership categories are as follows:

**Active Member:** Individuals, partnerships and corporations that *invest for their own accounts or for the accounts of others* in closely held companies or make investments which would traditionally be considered venture capital, angel or private equity investments.

**Associate Member:** Individuals, partnerships and corporations which *provide or offer products or services* to organizations that would be classified as active members.

In order to maintain the focus of the Forum on issues and concerns of the Active members, our *Associate membership is limited to a number equal to two times the number of Active members*. Additionally, each Associate member organization is **limited to two** representatives. The 2015 Associate members will be afforded the first opportunity to become Associate members in 2016; these applications for membership will be accepted without a nomination by an Active member. **New** applications for *Associate* membership will be accepted by the Forum as space becomes available and **when accompanied by a nomination** from an *Active* member.

**Meeting Information:** The monthly breakfast meetings are held on the 2<sup>nd</sup> Wednesday of the month at Maggiano's in Buckhead. Announcements will be sent via email approximately 2 weeks prior to the upcoming meeting. There are no meetings in July or August; the Southern Capital Conference constitutes the September meeting; and in lieu of a December meeting, we host an evening holiday party.

**Please submit the application in accordance with the following guidelines:**

***All Active, new Active and present Associate members:*** Mail the completed application and check to the address shown on the application (see dues structure on application).

***All new Associate members:*** Mail the completed application, check **and** nomination from an *Active* member to the address shown on the application (see dues structure on application). If your application is **NOT** accepted, you will be notified and your check will be returned.
